3) MINUTES OF PREVIOUS MEETING HELD ON 1st DECEMBER 2017

It was agreed that the minutes were a true and faithful record of what was discussed. No comments were made. Agreed by Peter Curry.

4) WORKS IN PROGRESS /PLANNED PROJECTS

- a) HES (AF)
 - i) Introduction of new names and roles within the Department.
 - Stirling Scott was employed for 17 years as a VLS Pilot, Stirling is now a Pilotage Operations Manager.
 - Tony Lewis was a Coxswain for 20+ years and is now the Marine Services Manager.
 - Graham Cudbertson is now the Marine Administration Manager.
 - Sally Lovett, Marine Admin Secretary covering maternity leave
 - ii) 2 incidents / MAIB reports published Year to date
 - iii) Peggotty discussed & awareness raised on the Humber for Pleasure craft. **ST** to visit Yacht Clubs / Mariners to deliver safety advice & programme of education.
 - iv) City of Rotterdam discussed. Simulators agreed confusion on bridge. (Relative motion illusion).
 - v) HMCC and MRC (Pollution Response) have now been relocated to Grimsby.
 - vi) New Survey Launch procurement in 2018
 - vii) New Pilot Launch planned in 2019
 - viii) Hornsea Windfarm.
 - ix) SDC Accretion phase at the moment.
 - x) PPU Investing this year.
 - xi) MCA Audit visited in 2017 very positive.

xii) New mooring infrastructure planned for Grimsby.

b) Personnel (AF)

Phil Christy is now appointed Dock Master GY & Immingham following Graham Hodge's retirement.

Tony Jones appointed as Deputy Dock Master, Immingham replacing Peter Stickland. Amanda Eland appointed as Marine Administration Assistant, Docks.

c) Grimsby (PC)

- Demolition of Coal Jetty to continue and hope to be completed by mid February, 2018.
- ii) Dock Walls are a 'listed' structure.
- iii) Repair works to be carried out on Dock Tower also a Grade 1 listed building.

d) Immingham (PC)

- i) Outer Lock Gates are fully operational.
- **ii)** After weekend, fully operational flood gates and no more closures are planned this year.
- iii) Middle gates due next in 2018.
- iv) SDC Accretion Exceeding dredge budget this year. Targeted area 36-48 surveys and assessments.
- v) Dredge Budget will be increased next year.
- vi) Outer Harbour Pontoon Accretion in the area and currently unable to dredge in there.

e) Hull & Goole (MC)

- i) 12 lock closures during the year. Delays have been minimised, further 2 weeks planned in 2018.
- ii) Alexandra GPH Dock Now fully operation. Busy period will be in 3rd Q next year. Ship berthed causing damage to the Dock, refused vessel & modifications requested & done.
- iii) Green Port Hull is now operational.
- iv) Werner Quay new to everyone. Simulator carried out this year.
- v) Weighted Heaving Lines 68 cases. Being replaced by a bean bag & financial penalty will be imposed. Report immediately to MCA.
- vi) Another Boatage company licenced in Goole.
- vii) Driving Safety campaign in Hull Speed Gun & Telephone usage etc proving successful and less cases.
- viii) Incident at Saltend reminder to all of lone working.
- ix) HCT new container crane will be in place by February 2018
- x) UKD Dredging levels have been achieved.
 Business as usual and maintain depths as best as we can. (AF)

f) HST

Humber Sea Terminal – Development work ongoing. Increased capacity by 50% containers / trailers. Renewed hydraulics at berths 1 & 3. Will accommodate larger Stena vessels from January 2018.

g) TRENT AND HAVENS (AF)

i) Working closely with PD Ports & RMS – 2 operators. On board with keeping in line with standards / boatage licence.

h) HCC RIVER HULL (P Curry)

- i) End of a busy year with "Hull City of Culture 2017".
- ii) Drypool Bridge. Land development / Heritage Centre.
- iii) Cruise Terminal always considering feasibility.
- iv) 5 year plan for River Hull, possibly 20 yr plan. River Hull will be closed at some point 2018 to allow piling works to be carried out on the river. This will have a large effect on the river.
- v) Port Safety Plan is in place.
- vi) River traffic in Hull has seen a decrease
- ** David Parkinson introduced himself as Hull Marina Manager and provided update re works on the lock gates. Would like "Educational Programme" extended to them and will liaise with **ST**. Had a very busy year in 2017 and historic ships also visited.

i) Tugs (KD)

<u>SMS</u> - 10 tugs. Iceman up for sale and Guardsman has gone to Portsmouth.
 Currently 8 in the fleet. No more planned departures/changes.
 <u>Svitzer</u> - Simon Lee has moved on. Awaiting update / no representative.

5) Environmental Matters

- i) Licensed disposal sites. Sampled sediments / analysing them prior to disposing at sea.
- ii) MMO 3 years sampling checks. 53 taken and generally speaking were ok. Levels of contaminant were as expected. Pesticides will be the focus next time.
- iii) Promote bio-diversity Whitton Island was released to RSPB for 50 years and has already proved a success in relation to nesting birds

6) Port Marine Safety Code (PMSC) Compliance

- Internal PMSC and Energy Audits during 2017 followed by MCA Health Check and full VTS audit both after completion of VTS & Data Centre relocation. A number of good practises identified.
- ii) In September, ABP's Designated Person, William Heaps retired and replaced by James Clark now Technical Authority Marine as well as Designated Person.
- iii) Port Marine Safety Code was published late 2016. Now accompanied by PMSC Guide to Good Practice, issued Feb 2017 & amended version September 2017.

7) CERS3 (GC)

- i) Thanks have been expressed from the CERS team to all agents and port staff providing information as there were very few errors within the voyages.
- ii) Few developments within 2018 interface to allow data transfer of Hazmat Information/ change to the way waste is reported & new workbook to reflect feedback / minor fixes.
- iii) GC also expressed his thanks to all during the CER3 implementation.

8) Emergency Response (GC)

- a) Humber Clean
 - i) HUMEX 2017 Took place 14/11/17. Exercise Collision of bunker barge at GRT. 10m3 gas oil spilt in river and 100m3 onboard vessel. Main purpose was to test the newly relocated Marine Response Centre (MRC), its communications & recent management changes. Fire drill also included in respect of HMCC & MRC evacuation procedures. As a result of HUMEX, the Humber Clean Oil Spill Contingency Plan has been amended and redistributed.

9) Conservancy (GC)

- i) So far this year, 160 Notice to Mariners issued, 97 of which were Shoal Water warnings and resulted in 20 buoy moves.
- ii) Survey craft conducted 604 surveys. New survey vessel planned with same specifications as Humber Sounder.
- iii) Hornsea Offshore Wind Farm (Zone 4) Project Two by Orsted (previously Dong Energy) is underway with UXO and boulder clearance operations completed and trench digging operations due to commence in early 2018.
- iv) Proposed Hornsea Three Project is in early stages of planning and projected to make land off Cromer. Anticipated Humber interest will be the potential shipping routes along the South East coast approaching the Humber being interrupted by usual preparation works. Will keep stakeholders updated.

10) Agents Online / Change of Agency

i) Still discrepancy within AOL regarding interport movements and the changing of Agents. The preferred system, in order to ensure correct pilotage, is to send a fax or email (fax line has been restored) accompanied by a phone call to Data Centre. Highlighted on the slide, available within PAVIS & AOLn – nominating a forwarding agent. This will allow both agencies access to a vessels voyage but not a commonly adopted practice.

11)VTS REPORT (ST)

a) HMCC Update – Completion of HMCC project. Broke ground on 22 August 2016 after contract given to Britcon. Building handed over in May 2017 to begin installation of Kongsberg Norcontrol C-Scope equipment and Cyfas VHF equipment. VTS Humber went live in Grimsby on 22/08/17. The resilience suite which is home to Marine Response Centre and the back up VTS Control Room went live when we conducted our HUMEX for 2017.

- **b)** For the year ahead Complete HMCC project at Spurn Point, continue with staff career development with V103/2/4/5 and work towards obtaining MCA accreditation to deliver V103/4/5 courses at MRC training suite at Grimsby.
- c) The VTS statistics show 245 reports ships defects, this is due to us having a more vigorous reporting system. (19 Pilot Ladder, 40 Bow Thruster, 186 reported to MCA)

Paul Daley – MCA. Advised of some changes, HUB includes Hull Marine and now incorporates Tyne Marine Office. Still bases at Beverley. Mick Groack in charge of the two and Lesley Copeland, Business Manager.

Peter Yates –Trustee/ Director for Seafarer Services. Spoke and promoted the facilities offered by Seafarer's Mission at Immingham. The mission relies on the £20 voluntary ship levi and would encourage more support by agents / ship owners.

42% of agents currently support the mission and would love to see this increase.
