# NOTICE TO MARINERS

## U P P E R H U M B E R

### MOVES OF FLOATING MARKS AND SHOAL WATER

**NOTICE IS HEREBY GIVEN** that it is proposed on Thursday 25<sup>th</sup> July 2024 (or as soon after as circumstances permit) to move: -

- 1) The No. 33 Light Float to the following position:  
Latitude 53° 42.027' N, Longitude 0° 33.917' W (WGS 84)  
(59 metres South of its current position)
- 2) The Middle Whitton Light Float to the following position:  
Latitude 53° 42.444' N, Longitude 0° 34.498' W (WGS 84)  
(82 metres North-West of its current position)

**MARINERS ARE WARNED** that on completion of the above moves the following shoal water will exist: -

- 1) A least depth of 1.4 metres **ABOVE** Chart Datum exists North of the ships course 308 metres downstream of the Lower Whitton Light Float.  
Deeper water exists on the ships course in this vicinity.
- 2) Depths of between 0 metres at Chart Datum to 0.4 metres **ABOVE** Chart Datum exists North of the ships course 550 metres downstream to 330 meters upstream of the No. 32A Light Float.  
Deeper water exists on the ships course in this vicinity.
- 3) A least depth of 0.1 metres **ABOVE** Chart Datum exists close South of the ships course in the vicinity of the Cappers West Light Float.  
Deeper water exists on and to the North of the ships course in this vicinity.

- 4) A least depth of 0.6 metres **ABOVE** Chart Datum exists North of the ships course 240 metres upstream of the No.33 Light Float.

Deeper water exists on the ships course in this vicinity.

- 5) A least depth of 0 metres at Chart Datum exists South of the ships course in the vicinity of the No.33A Light Float.

Deeper water exists on the ships course in this vicinity.

- 6) A least depth of 0 metres at Chart Datum exists North of the ships in the vicinity of the No.32C Light Buoy.

Deeper water exists on the ships course in this vicinity.

**MARINERS ARE ADVISED** that on completion of the above moves, 0 metres at Chart Datum should be used for passage planning purposes and Notice to Mariners No. H. 90/2024 is hereby cancelled.
